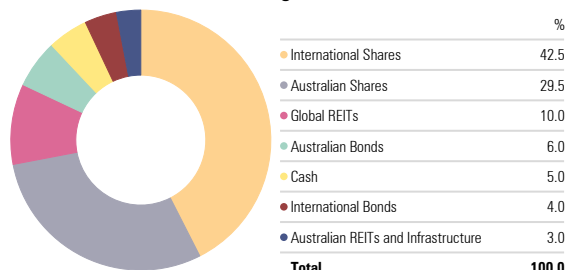

Investment Objective

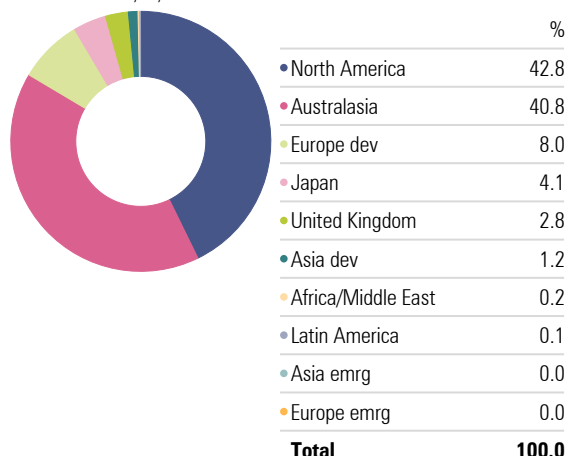

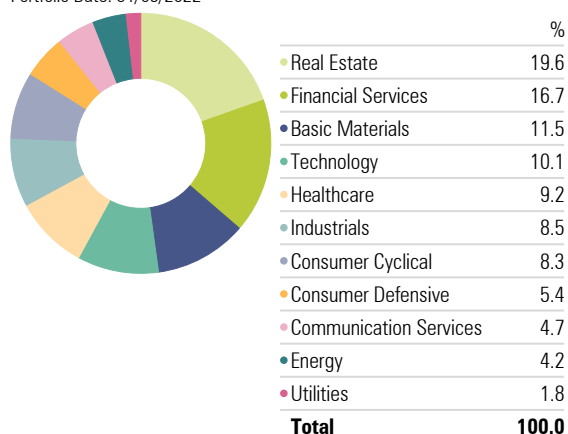
