INVESTMENT OBJECTIVE

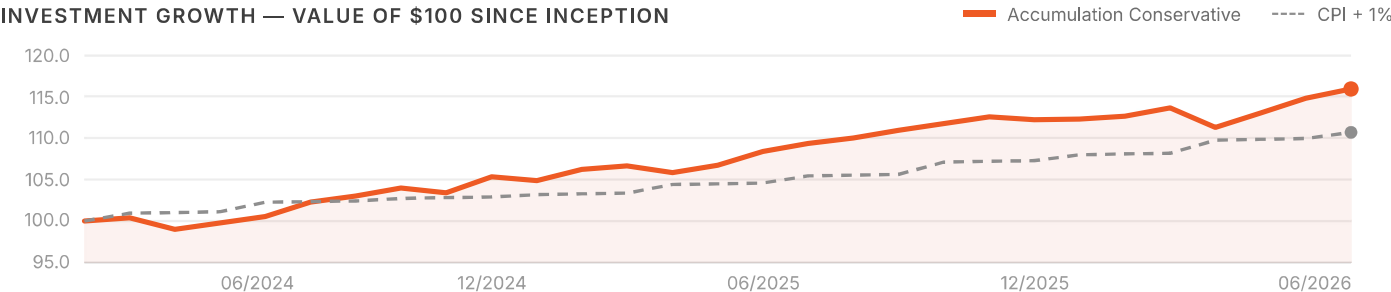
